PERSONAL LICENSE AGREEMENT FOR ADVEXSOFT DISK SPACE INSPECTOR SOFTWARE

IMPORTANT-READ CAREFULLY!

This AdvexSoft LLC End-User License Agreement ("EULA") is a legal AGREEMENT between you and AdvexSoft LLC for the AdvexSoft LLC software product identified above, which product includes computer software and may include associated media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA.

SOFTWARE PRODUCT LICENSE
